## **POLICIES**

**Food/Drink:** Absolutely no food or drink is allowed on/in the inflatable toys.

**Payment:** Payment in full must be received on or before the day of the actual event. Renters can pay by credit/debit, cash or Pay Pal.

**Legal Group Representative:** The legal group representative (person who signed the rental agreement) or a person so designated must be on site at all times to insure the proper placement of equipment, to insure that the property is left undamaged and to ensure the property is being used correctly during the rental period. Renters of multiple toy events must provide one person per toy during operating hours to oversee the safe use of each toy. A printed version of the *General Rules of Operation and Training Manual* is available at [www.supersonicbounce.com](http://www.supersonicbounce.com) or upon request.

**Returns:** All inflatable toys must be returned to 696 N 1000 E Bountiful, UT 84010 by the time stated on the rental agreement. A 30 minute grace period will be given. If inflatable(s) are not returned by the end of the 30 minute grace period a fee of \$100 will be added to the balance owed to Supersonic Bounce.

**Weather:** Heavy rain–The safe operation of equipment is severely compromised if rain is steady. The toys will be temporarily shut down during heavy rain and each toy will sufficiently dried

Wind – The safe operation of equipment is even more dangerous in wind. Toys will be closed temporarily and deflated in case of high winds.

**Participant Conduct:** Participants are asked to follow the rules at all times. The legal group representative (person who signed the rental agreement) is responsible for ensuring that all participants using the inflatable follow safety rules.

**Event waivers** Event waivers must be filled out and signed by all legal group representative (person who signed the rental agreement).

\_\_\_\_\_ **I understand that before returning inflatable toy(s) it is my responsibility to insure the toys are swept clean and free of grass, leaves, debris, personal belongings... (sweeping or using a shop vac are suitable ways to clean inside of toys)**

\_\_\_\_\_ **I understand that when the inflatable toy is returned, if it is not returned rolled in the same way it was when I rented it, and put back in the bag if it comes with one, I will be charged a \$30 re-rolling fee.**

\_\_\_\_ **STAKES I understand that I will be charged \$5 for each stake not returned with inflatable toys.**

In the event that I file a cause of action against Supersonic Bounce, I agree to do so solely in the state of Utah, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect.

I acknowledge that I (or my legal guardian) have adequate homeowner's insurance, tenant insurance, or other liability insurance to cover my bodily injury or property damage which might occur to myself, my guests, or my invitees from the use of the unit(s) I am participating on, and I agree to bear the costs of such injury or damage myself.

## **Supersonic Bounce LLC Basic Safety Instructions**

A minimum of one responsible adult must be supervising each inflatable at all times.

NO Shoes on inflatables.

No climbing on outside walls of inflatables.

Enter and exit the ride at the appropriate entrance and exit.

Children and adults enter the rides one at a time.

Lightweight children and heavy children/adults do not jump on bounce houses or inflatables at the same time.

No one over 100 pounds allowed on kiddie rides.

If heavy wind or wind gusts arise, inflatable must be deflated.
